

NOTICE OF PUBLIC HEARING

INTENT TO DISCONTINUE THE CITY OF SWAN, IOWA

Notice is hereby given that the Swan City Council will hold a public hearing, on **THURSDAY MARCH 27TH at 6:15 p.m.** on the proposed discontinuance of the status of incorporation of the City of Swan, Iowa, Marion County. It is due to lack of interest and participation in the local governing process and increasing costs to the city finances that the council is considering this discontinuance.

Public Hearing will be held on Thursday March 27th, immediately following a Special Hearing on the 2025-2026 Swan Tax Levy at **104 Orchard Street, Swan, Iowa 50252**. The meeting will be open to the public for questions or comments to the City Council.

Notice is further given that the City Council intends to act and vote on a Resolution to Discontinue or a Resolution to Abandon the proposal on that date and time or at a later meeting .

This notice is given in accordance with and pursuant to Iowa Code Sections 368.3(2), and 362.3(1)(b).

RESOLUTION NO 03-25

A RESOLUTION OF THE CITY OF SWAN, IOWA, MARION COUNTY, IOWA, DECLARING IT TO BE THE INTENTION OF THE CITY COUNCIL TO DISCONTINUE THE STATUS OF INCORPORATION OF THE CITY OF SWAN, IOWA.

BE IT RESOLVED by the city council of the City of Swan, Iowa, as follows:

Intent to Dissolve. Pursuant to Iowa code 368.3 (2), It is the intention of the council to approve a resolution to discontinue the incorporated city of Swan, Iowa.

Planning and Liquidation. Upon approval of this resolution, preliminary coordination with the Marion County board of supervisors and other appropriate bodies will begin with the intention to plan for liquidating assets, transferring of contracts or services as appropriate. No actions will be taken on said planning until or unless the council passes a resolution of discontinuance after appropriate public hearings have occurred.

Public Hearing: Upon approval of this resolution, a public hearing will be set for March 27th, 2025, at location 104 Orchard Street, Swan IA 50252, where residents, property owners, or other interested parties may share written or oral comments on the matter with the council. At the same meeting or at a subsequent meeting, the council may pass a resolution of discontinuance or pass a resolution abandoning the proposal.

If the council passes a resolution of discontinuance, a petition may be filed with the clerk in the manner provided in Iowa code section 362.4, within thirty days following the effective date of the resolution, requesting that the question of discontinuance be submitted to the registered voters of the city.
